## Composting

Residents have the option of using a composting service called **Waste Well**. Waste Well picks up food scraps from customers and delivers them to a composting processing facility. Each spring, their customers receive a lot of finished compost as well. [Find more information](#).

For service on your well equipment, you will generally find a label on your water tank from the firm that performed the original installation. ## On-Lot Septic:

**SEPTIC PERMITS:** As of **June 1, 2023**, the Delaware County Health Department (DCHD) is responsible for inspections, investigations, permit issuance, and enforcement for the installation of individual and small community on-lot sewage disposal systems. For Septic Permit information. **EXISTING SEPTIC SYSTEMS:** CHADDS FORD Township will still review permits associated existing septic systems (i.e. additions, pools, etc.).
